Invites you to enter our annual juried painting exhibition, *¡ENCANTADA! 2010*, to be held at the Art Gallery at The Inn at Rio Rancho, New Mexico from October 1 to October 30, 2010.

*¡Encantada!* is open to all artists over the age of 18 submitting entries according to the requirements in this prospectus.

### JURORS

A panel of three well known artists will rank entries to determine which will be included in the exhibition.

### JUDGE

The judge will make the award selections from the actual artwork after exhibition is hung. The awards will be announced at the opening reception.

Over \$3500 in cash and prizes were awarded at last year's show, including a \$750 1<sup>st</sup> Place.

### ELIGIBILITY

All entries must be original work completed since May 2008. Entries previously shown in an RGAA juried show, copied from another artist's work or published material, or accomplished as a student under supervision are ineligible. Source material must be available to RGAA officials upon request.

### ACCEPTED MEDIA

Two-dimensional, dry-to-touch painting must be exhibited **without protective covering (such as glass)**. Acceptable media includes: oil, acrylic, casein, egg tempera, mixed media and, oil pastel. Work must be at least 80% paint.

### SIZE

Maximum width including frame: 50"  
Minimum width including frame: 12"

## SUBMISSION OF ENTRIES

Each artist may submit a maximum of 3 entries. Entries must be submitted by digital photo (JPG), and emailed, AS ATTACHED IMAGES, to [reelartist@yahoo.com](mailto:reelartist@yahoo.com)

PLEASE do not embed the image in the email.

Digital Specifications

- JPG file

- Resolution: 72 dpi

- Image size: maximum of 700 pixels on the largest dimension. **For best juror viewing, we encourage you to set the dimensions to 700 pixels.**

- Photo should be cropped to show image only (no visible frames, etc.)

- FILE NAME CONVENTION: 1<sup>st</sup> 4 letters of last name, 1<sup>st</sup> 4 letters of first name, entry A, B or C

**Example:** Jonathan Smith has three entries:

smitjonaA - first entry file name;

smitjonaB - second entry file name;

smitjonaB - third entry file name

**Only properly prepared and labeled images will be accepted. In addition to the emailed images, RGAA must receive by mail the completed and signed entry forms, fees and SASE from each entrant.**

**Deadline for receipt of digital files, entry forms, fees, and Stamped, Self Addressed Envelope is Friday, July 30, 2010**

### JURY NOTIFICATION

### ACCEPTED WORK

All artwork must be sturdily framed or gallery wrapped (minimum 1 1/4 inch thick and edge painted), with hanging wire attached. **Wire must peak 3 1/2 inches from top of frame or wrap.** No name plaques may be attached to the frames.

**All work must be for sale and prices cannot be changed after acceptance.** RGAA will retain 30% of the sale price plus NM sales tax for any paintings sold during *Encantada! 2010*.

### HAND DELIVERED WORK

Artwork must be delivered to the **Art Gallery at the Inn at Rio Rancho, 1465 Rio Rancho Blvd., S.E. on Wednesday, September 29, from 9 am – noon - ONLY.**

### SHIPPED WORK

If work must be shipped, send to: **RGAA Show, c/o The Mail Bank, 1208 San Pedro Dr. NE, Albuquerque, NM 87110 (phone 268-9798).** Artwork must be received by **Monday, September 27.** Shipping to and from the show is the responsibility of the artist. An additional handling fee for unpacking, inspecting, re-packing in original materials, storage of the packing materials and transporting to and from the exhibition site will be charged: **\$45** for the first painting, **\$20** for each additional painting in the same strongbox; **\$55** and **\$20** for crated.

### RETRIEVAL OF WORK

**All unsold hand-delivered work must be picked up by the artist or representative at the Inn at Rio Rancho on Sunday, October 31 from 9 am until noon.**

Shipped artwork will be picked up by Mail Bank and re-shipped back to artist per pre-paid arrangements. Artwork not picked up at end of show becomes the property of RGAA.

## AGREEMENT OF ENTRY & LIABILITY

All reasonable care will be taken with entries and paintings. However, neither RGAA, its officers or volunteers, The Inn at Rio Rancho or its employees, or employees of the shipping agent will be responsible for loss or damage. RGAA strongly recommends participants carry independent insurance. All accepted work (**no substitutes**) must be delivered or shipped as specified in this prospectus. **If accepted work is not available for the exhibition or does not meet the criteria stated in this prospectus, the artist must pay RGAA a 30% commission on the stated sales price.** RGAA reserves the right to reject any work which varies from the entry submission, or any work deemed unsuitable for public viewing. RGAA reserves the right to reproduce accepted artwork for publicity purposes.
